

COVID-19 (Coronavirus) Resources for Nonpublic Schools and Local School Systems That Intend to Reopen School Year 2020-2021

August 20, 2020 -- All nonpublic schools and local school systems that intend to reopen this school year for inperson classes and instruction should develop and implement a plan for reopening that addresses mitigating and controlling COVID-19 and should develop operational policies and procedures to protect the health and safety of students, parents and guardians, and staff.

Each reopening plan shall cover the following prevention and mitigation strategies to slow and limit COVID-19 exposure and spread:
